- **Other Incidents**

Rangers assisted Rancho Cordova PD by locating a vehicle involved in a carjacking. The vehicle was located along the American River Parkway by Northgate. Rangers arrested one of the occupants for being a parolee at large and turned the other occupant and vehicle over to Detectives working the carjacking case. Rangers also arrested an individual for carrying a loaded flare gun concealed on his person as well as possession of methamphetamine. He was contacted along the American River Parkway by Northgate Blvd.

Rangers were checking camps along the American River Parkway by Ambassador Access, when a person ran from Rangers. He was apprehended after a foot chase. He had a felony warrant for his arrest. He also had stolen property from a nearby burglary as well as methamphetamine in his possession.

Rangers responded to a disturbance by mile marker 3.5 along the American River Parkway. During the investigation, it was determined that one individual armed himself with a shovel and a stick and struck the other individual in the head causing an injury to his ear. Rangers were able to locate the suspect and arrest him for assault with a deadly weapon.

The Park Resource Team investigated two cases of possession of narcotics for sale along the American River Parkway. One case was along the Two Rivers Trails, and the second case was by mile marker 3.5. These two investigations resulted in two people being arrested for possession of illegal drugs for sale. The case along mile marker 3.5 also resulted in several dogs being seized by animal control. These dogs are suspected in 3 dog bite cases during the last several of months.

Rangers also spent a significant amount of time dealing with flooding issues along the American River Parkway this month. The lower portions of the American River Parkway and Steelhead Creek flooded in February. Rangers did spend some time advising the homeless to seek higher ground prior to the storms.
