- Numerous illegal campers on the bridal trail near Cal Expo.
- Illegal camping near howe access on old paved trail just west of Howe access on South side of river.
- Dog off leash Behind Staging area but on trail- running with owner.
- There is still a relatively large amount of homeless camp stuff at the east end of the cove – Howe

- There are several street lights not working. Discovery
- I saw two women setting up a camp site near the river at Sutter's Landing Park.
- Homeless have set up a camp in field behind our house (between Dry Creek Road & Cherry Lane).
- Tent 8x10 set up in Riverbend Park. This tent is about 75 feet from the one I reported last week.
- Illegal camp -North side of Camp Pollock
- Two illegal camps #1: About 50-75 yards east of mile marker 18.
 #2: 0.5 mile west of Watt Ave bridge on the south riverbank.
- 12!! dogs off-leash on horse trail at Sailor Bar. There were also many dogs off-leash all along the river. 2 different encounters with bicyclists on horse trail
- Saw the grazing sheep/goats and was very please at this mixed use.
